TERMS & CONDITIONS:

1. This appointment is made as per employment rules of MGM Medical College and Associated Hospitals (Autonomous Society), Indore.
2. The appointment is made on a consolidated salary of Rs76,000 (Rs Seventy Six Thousand only) per month and will not attract any allowance of any nature.
3. On completion of duration of the 1 year, it will be extended for the next year on the basis of the recommendation made by The Head of the department regarding the satisfactory work of the concern (for maximum 3 years tenure)
4. The appointment can be terminated without prior intimation by the Dean & CEO at any time after receiving unsatisfactory report from the Head of the Department and review committee.
5. Appointees are entitled for 12 days casual leave (not more than 7 days at a stretch) & one day weekly off only. Such weekly off can not be accumulated.
6. Appointees are neither allowed private practice of any kind nor to be under any sort of employment, any where, during the tenure of employment with this society. They shall have to submit an undertaking to this regard prior to joining their duties.
7. Appointees will be under the direct control and supervision of the concerned Head of the Department and shall obey his/her verbal & written orders and shall maintain discipline in terms of attendance, duties, work allotment, patient care and any other discipline norms followed in the Department, & as and when required they have to do C.M.O. duties.
8. The appointed candidate shall report to the District Medical Board for a medical check up and shall submit a fitness report, issued by the said authority, at the time of joining.

The last date of joining is 21.09.2023 thereafter the appointment will be automatically cancelled.

10. Appointees shall submit their joining to the concerned Head of the Department, in triplicate along with relevant undertaking & medical fitness certificate, who shall forward two copies to the college office.
11. The candidates are required to present their original documents in the college office which will be returned to them after verification.
12. In case the candidate is not registered with M.P. Medical Council, he/she should submit the registration within one month to this office otherwise his/her services is liable to be terminated.
13. The appointment will be valid only after getting clearance through police verification.
14. Services can be terminated by either side by giving one month notice or one month salary. If the candidate resigns without giving one month notice or without depositing one month salary, as per terms & conditions, the amount of salary will be recovered from the candidate as per due land revenue recovery.
15. Candidate will have to submit proof of resignation from previous job (if any) before joining.
